**\*WARNING NOTICE\***

Dear Mr. [REDACTED]:

The Division of Food and Recreational Safety at the Department of Agriculture, Trade and Consumer Protection has received information that you are selling eggs from [REDACTED], Hillsboro, Wisconsin, and shipping them to consumers without a current Retail Food Establishment license. Because you do not hold a valid license from our Department to hold, process, package or sell the eggs, you shall not hold, process, package or sell the eggs for human consumption from your home or any other location. Any food products, including eggs, that are held, processed, packaged, or sold in Wisconsin by you will be considered adulterated product from an unlicensed facility.

The selling and shipping of eggs without a license is in violation of Wis. Admin. Code 88.02. In addition, Wis. Admin. Code 88.18(2) requires that once eggs are packed, they are to be kept at an ambient temperature of 45°F or less, including while they are in transport.

Until you have obtained a Retail Food Establishment license from our Department, you must Cease and Desist from the holding, processing, packaging, or selling of eggs. I am requesting that you contact our Licensing Unit via e-mail at [datcpdfslicensing@wisconsin.gov](mailto:datcpdfslicensing@wisconsin.gov) or at 608-224-4923 to discuss the specific food operation activities you are performing with one of our licensing specialists who will be able to assist you in obtaining the licensing application for the appropriate food license that is required.

Please note that the **Licensing Unit** returns all phone calls and responds to all e-mails in a timely fashion and **is the resource that will ultimately be able to answer your licensing questions;**
